

RULES & REGULATIONS [Will live on Boston Tweet Blog and be linked to directly during the Scavenger Hunt on Friday, April 21 from 11:00 a.m. EDT to 1:00 p.m. EDT]

- To participate, go to www.twitter.com (the "Twitter Website"), or on your wireless phone's Twitter App, and (1) if you already have a Twitter account, log on using your Twitter user name and password or (2) if you do not already have a Twitter account, create a free Twitter account according to the instructions on Twitter Website. Please note that you must agree to comply with the Twitter Terms of Use in order to create a Twitter account. You will then be required "follow" Tom O'Keefe, or, "@BostonTweet," look for a Tweet from Boston Tweet relating to Boston Tweet Seaport Sweepstakes containing a clue and a picture as to the Location of a hidden Prize. You can also participate by going to www.instagram.com (the "Instagram Website"), or on your wireless phone's Instagram App, and (1) if you already have a Instagram account, log on using your Instagram user name and password or (2) if you do not already have a Instagram account, create a free Instagram account according to the instructions on Instagram Website. Please note that you must agree to comply with the Instagram Terms of Use in order to create an Instagram account. You will then be required "follow" Tom O'Keefe, or, "@BostonTweet," look for an Instagram post from Boston Tweet relating to Boston Tweet Seaport Sweepstakes containing a clue and a picture as to the Location of a hidden Prize. The objective is to identify the Location, travel to the Location, be the first person to find the envelope at the Location, and be the first to correctly answer the question found in the envelope in a Tweet or Instagram Post tagging @BostonTweet on Twitter or @BostonTweet on Instagram. b. Two winners will be selected by whomever arrives first at the disclosed location provided by Boston Tweet and whomever answers correctly the question provided in the envelope, taking a picture of the question and posting on Twitter or Instagram with their answer to that question, and from among all eligible entries received. Winner will be notified onsite at the disclosed location.

c. Prize or instructions to retrieve the prize will be provided in person at the disclosed location.
